<sup>(1)</sup> By its Resolution 22 GA 7, the General assembly of the States Parties to the Convention concerning the Protection of the World Cultural and Natural Heritage has decided that the contributions to the World Heritage Fund is set at 1% of each State's contribution to the regular budget of UNESCO. The General Assembly also reiterated its plea to the States Parties to pay their annual contributions at the latest on **31 January** wherever possible in order to facilitate the timely implementation of the activities financed by the World Heritage Fund.

As requested under Resolution 19 GA 8 (<http://whc.unesco.org/en/decisions/6423/>), the Director-General invites States Parties to make unrestricted supplementary **voluntary** contributions to the World Heritage Fund in addition to their mandatory contributions. By its Decision 40 COM 15 (<http://whc.unesco.org/en/decisions/6854/>), the World Heritage Committee endorsed options 1, 4 and 5 of Resolution 19 GA 8, as they were found applicable alternatives presented to the 19th General Assembly. By the same decision, the World Heritage Committee also endorsed the proposal of document WHC-15/20.GA/8 (<http://whc.unesco.org/archive/2015/whc15-20ga-8-en.pdf>) presented to the 20<sup>th</sup> General Assembly to apply on a voluntary basis a minimum contribution by categories to complement the assessed contributions.
